### Terms and conditions of use

#### 1. Introduction

- 1.1 These terms and conditions shall govern MBA.
- 1.2 By using our services, you accept these terms and conditions in full; accordingly, if you disagree with these terms and conditions or any part of these terms and conditions, you must not use our services.

#### 2. Investing / registration and accounts

- 2.1 To be eligible for a MBA membership user will need to pay an annual fee
- 2.2 **All attending members** of the week may be required to pay an excessive cleaning fee for caretaking costs of equipment and staying 15 minutes past allotted time inside the gym.

#### 3. MBA: RULES

- 3.1 Your behavior must not be illegal or unlawful, must not infringe any person's legal rights, and must not be capable of giving rise to legal action against any person.
- 3.2 Under Murkville Basketball Constitution Act (2022) the standard rules for compliance:
  - (a) Non-investors (substitutes) must pay \$5 which is the standard issue of payment regarding to basketball runs.
  - (b) Must e-transfer the exact amount to tyrombis@gmail.com
  - (c) Sub payments must be paid in **full amount before the date** of basketball play. If payment not made, foul calls will not be called or respected.
  - (d) Missing game day must be reported to the commissioner via (WhatsApp, IMessage, Etc.) 24 hours of notice (with reason) before basketball play. If player does not notify they are subjected to penalties in clause (f).
  - (e) If you cannot attend on the date of basketball play, the commissioner will find a replacement.
  - (f) All players must arrive in the gym (prepared to play) by **8:45 pm**. Any tardiness will resolve in disciplinary action (verbal warning, second warning (+ no foul calls), suspension (1 month).
  - (g) Investors must decide if they will be attending every week by Monday night 11:59 pm via WhatsApp.

- (h) Cleanliness must be kept around the gym at all times. Trash must be thrown in the garbage can. No tampering with school equipment or damaging the premises.
- Any racial or religious hatred or discrimination will be subjected to immediate ejection off the court.
  This applies to political views and opinions on certain sensitive topics.
- (j) Fighting/beef will not be allowed on court and will be subjected to immediate ejection off court and may result in suspension.
- (k) Fighting/beef must be handled accordingly (off-court and outside premises of the building)
- Murkville Basketball does not condone to any violence or misconduct of any MBA player.
  (Individuals must settle it between the two parties)
- (m) York Region District School Board (Board) may delay the start or cancel your permit at any time in response to public health measures, direction from the Ministry of Education and to accommodate operational requirements of the Board. All paid funds will be carried over into the next season.
